



DEAR WATER STEWARDS

As the CEO Water Mandate, a partnership of the UN Global Compact and the Pacific Institute to advance corporate water stewardship, advances on its ambitious 2030 goals to build a water-resilient future, we are excited to share this year's Impact Report. The pressing nature of global water challenges underscores the pivotal role of the CEO Water Mandate, amplifying its significance in addressing the urgent needs of water security worldwide.

Here is the reality check. Global water use is predicted to outstrip supply by up to 40 percent by 2030, just six years from now. Further, water availability is becoming less predictable in many places, in part due to climate change. According to data from WRI's Aqueduct Water Risk Atlas, 25 countries, home to one-quarter of the global population, experience extremely high-water stress annually, often depleting nearly all of their available water resources. Additionally, at least 50 percent of the world's population, approximately 4 billion people, face highly water-stressed conditions at least one month each year. In many regions, intensifying droughts are exacerbating water scarcity with negative impacts to people, nature and economies.

The bottom line? The world is not on track to meet Sustainable Development Goal (SDG) 6 for Clean Water and Sanitation by 2030. According to the United Nations' 2023 Sustainable Development Goals Report, achieving SDG 6 targets by 2030 will require a significant increase in current global rates of progress. Specifically, it would mean a six-fold increase for drinking water, five-fold for sanitation and three-fold for hygiene.

The private sector, as both a significant consumer of water and a powerful lever of change, finds a unifying platform in the CEO Water Mandate, which proudly convenes companies to collectively address water challenges through action.

The year 2023 was an important year for the CEO Water Mandate. We are now 242 companies making a huge impact in building water resiliency.

A landmark achievement took place during the UN 2023 Water Conference – the first of its kind in almost 50 years. To leverage the power of the private sector to advance water solutions, the CEO Water Mandate launched the Business Leaders' Open Call for Accelerating Action on Water. The Open Call's and the WRC's 2030 ambition — for businesses to build water resilience in operations, supply chains and 100 water-stressed basins — was adopted as the water resilience target of **the Forward Faster** initiative of the UN Global Compact launched in September 2023.

Alongside the 2023 UN Water Conference, the CEO Water Mandate's Water Resilience Coalition (WRC) launched an Investment Portfolio strategy with five leading corporations contributing to the \$150 million WaterEquity Water Access Fund, facilitating equitable access to water, sanitation and hygiene.

In October 2023, the WRC launched the Women + Water Collaborative, an initiative aimed at improving access to clean water and sanitation in India, while putting women at the center of local water solutions. This is one of 21 collective action projects in 15 basins underway across Asia, Africa, South America and North America as part of the Water Resilience Coalition's 2030 ambition to build water resilience across 100 Priority Basins.

WASH4Work, the CEO Water Mandate initiative to mobilize business action on water, sanitation and hygiene in workplace operations in communities where companies operate and across supply chains reached 401 signatories to its WASH Pledge in 2023.

Throughout the year, the CEO Water Mandate continued to provide tools to help organizations harness the power of Nature Based Solutions (NBS) to enhance water resilience, benefiting ecosystems, economies and communities.

The Water Action Hub, a global online collaboration and knowledge-sharing platform for water sustainability and climate resilience, continues to grow. Active users of the Water Action Hub increased to an all-time high of 4,700 in 2023 from 3,500 in 2022. Likewise, the number of water and climate projects uploaded to the Hub increased to 2,150 from 1,835.

We look forward to driving the business role in water stewardship and taking further steps in achieving net positive impact in 100 priority basins worldwide through collective action.

OUR MISSION

Transparency: Commit to transparency and disclosure in order to be accountable and meet stakeholder expectations.


STEERING COMMITTEE



DRIVING WATER RESILIENCE IN ACTION

WATER ACTION HUB

The Water Action Hub updated its user interface to increase accessibility and released several new functions, including an interactive map of the CEO Water Mandate's 100 Priority Basins and the World Health Organization/United Nations Children's Fund (WHO/UNICEF) Joint Monitoring Programme's Water Supply, Sanitation and Hygiene global data. Active users of the Water Action Hub increased from 3,500 in 2022 to an all-time high of 4,700 in 2023. Likewise, the number of water and climate projects uploaded to the Hub increased from 1835 to 2150.

WATER, SANITATION AND HYGIENE BENEFITS ACCOUNTING FRAMEWORK

The CEO Water Mandate hosts the WASH4Work Initiative to mobilize and support corporate action on access to safely managed drinking water, sanitation and hygiene (WASH) in workplaces, supply chains and communities. In 2023 a draft multi-benefit accounting framework was released for corporate piloting. This new WASH benefit accounting framework aims to standardize the way companies account for and report on the outcomes and impacts of corporate actions on WASH. It includes evolved leading practice indicators such as climate-resilient WASH, gender equity and financial return on investment. The final framework and guidance for corporate use will be released in June 2024. This WASH framework aligns with the Net Positive Water Impact ambition and guidance.

LAUNCH OF 100 PRIORITY BASINS

The 100 Priority Basins represent critical water-stressed areas home to over 3 billion people. Available on the Water Action Hub, the basins define the geographic scope of the WRC's 2030 strategy. The list of priority basins was born from a collective effort with the Alliance for Water Stewardship, Good Stuff International, the Pacific Institute, The Nature Conservancy, WaterAid, World Resources Institute and World Wildlife Fund. These basins serve as convening points for collective action projects to build positive water impact that moves the needle on basin-level resilience indicators.

LAUNCH OF FIRST WRC INVESTMENT FUND

In 2023, the WRC launched its Investment Portfolio Strategy to support the increase of private capital investments in water resilience by leveraging the capital markets. At the United Nations 2023 Water Conference, the initiative's first collective corporate investment commitments were announced with WRC partner companies Starbucks, Ecolab, Gap Inc., Reckitt and DuPont alongside the US International Development Finance Corporation, contributing to the USD\$150 million Water Equity microfinance fund for water and sanitation access. This first set of investment commitments has demonstrated the opportunity of the investment portfolio strategy—to invest in water resilience through proven, market-based solutions to maximize social impact, generate financial returns, and achieve the WRC's collective action goals. In addition, a multibillion-dollar pipeline of investment opportunities has been identified for further corporate engagement. Investment themes are aligned with the Net Positive Water Impact ambition, such as: nature-based solutions; waste-water reuse infrastructure; and WASH access investment opportunities.

NET POSITIVE WATER IMPACT PILOTING

In 2023 the WRC completed the first draft of the Net Positive Water Impact guidance. Seven Water Resilience Coalition companies spent around four months reviewing the guidance and internal tracking framework. Together with expert partners including Ceres, Ross Strategic, Diageo and WaterAid, these companies worked to trial the resource ahead of release in 2024.

The global water agenda has made significant advances in recent decades. As the effects of climate change increase water stress globally, businesses are stepping up and joining forces to secure our collective humanitarian and economic futures.

Positively, water is gaining a spotlight in the global agenda and the CEO Water Mandate has leveraged the power of global convenings to drive action on water resilience.

In 2023 the United Nations hosted its first Water Conference in 47 years. Leveraging this historic moment, the CEO Water Mandate, through the WRC, rallied the global business community around a shared vision: **positive water impact in 100 Priority Basins by 2030.**

Also during the United Nations Water Conference, the CEO Water Mandate partnered with the International Chamber of Commerce, Ceres, the Alliance for Water Stewardship and AquaFed to launch the **Business Leader's Open Call to Accelerate Water Action.** Fifty of the world's largest corporations, operating in over 130 countries and employing 2 million people worldwide, joined the Open Call at its launch in 2023.

The CEO Water Mandate continued building the movement at United Nations General Assembly in September 2023. During this week, the United Nations Global Compact launched the Forward Faster initiative to accelerate business action across five areas: Gender Equality, Climate Action, Water Resilience, Finance and Investment.

Forward Faster adopted the 2030 ambition of the WRC and Open Call as its water resilience target. By the end of 2023 over 100 additional companies across the three initiatives had joined the movement.

Momentum continued to build at COP28 in Dubai where the 100 Priority Basins ambition was recognized as a high-level outcome of the conference. This kind of recognition gives the 100 Priority Basins critical global legitimacy as we continue to build and mobilize the program.


